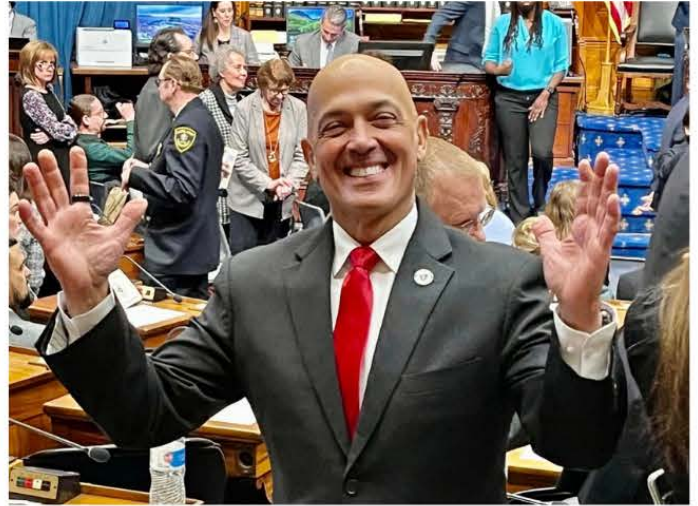

To begin the 193rd General Court of Massachusetts, my office has filed 28 bills for this session as a part of my Legislative Agenda over the next two years.

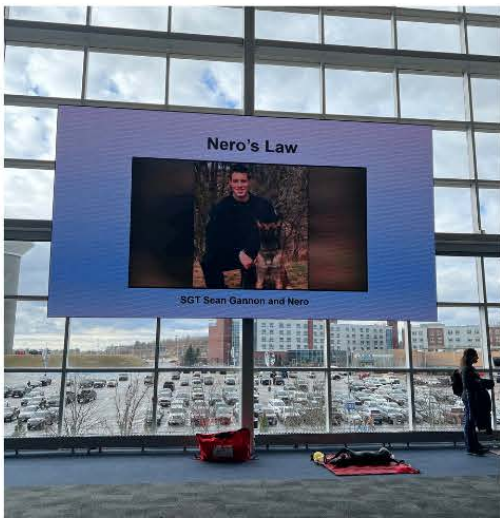


- **HD64.** An Act Relative to School Safety.
- **HD600.** An Act Relative to the Security of Exercise Equipment and Free Weights in Correctional Institutions (**Matt's Law**).
- **HD700.** An Act Relative to Assault and Battery Against Healthcare Personnel, School Officials, and First Responders.
- **HD1834.** An Act Relative to Enhanced Penalties For Those Who Commit Assault and Battery Against School Sports Officials.
- **HD208.** An Act Relative to Fentanyl Arrests (**Tatiana's Law**).
- **HD3881.** An Act Establishing a Fund for the Care of Retired Police Dogs.
- **HD1121.** An Act Relative to Providing Advanced Life Support to Police Dogs Injured in the Line of Duty.
- **HD3652.** An Act Relative to the "Move Over Law".
- **HD2721.** An Act Relative to Wastewater Treatment and Disposal in the Town of Sandwich.
- **HD3686.** An Act Relative to Bail Fees.
- **HD2687.** An Act to Study the Establishment of a Statewide Registry of People Convicted of the Sale of Certain Class A Drugs.
- **HD206.** An Act Calling on Article V of the United States Constitution for the Convention of States.
- **HD207.** An Act Regarding Right of Way Violations (**CeCelia's Law**).
- **HD130.** An Act Relative to Emergency Response in an Active Shooter or Hostile Event Situation.
